FOI-25-42:

1. The latest audit report to understand the extent and condition of asbestos in your social housing stock in the past 10 years.

In the spring of 2024, Derby Homes commissioned a stock condition survey to be undertaken in relation to the Housing Stock. The survey is still being carried out. At the date of the request, we have accessed 8846 properties. Asbestos is one of the elements assessed in the survey.

A redacted output of the properties surveyed is contained in the tab "Stock Condition Survey" on the attached Excel document.

In the winter of 2020, Derby commissioned a contractor to undertake Asbestos management surveys of all communal areas within blocks of flats. A redacted output of the areas surveyed is contained in the "communal 5-year checks" on the attached Excel document.

We undertake an Asbestos Management or Refurbishment surveys on the housing stock when properties become void, depending on whether or not works are required.

A redacted output of a small sample of properties surveyed is contained in the "Void sample example" on the attached Excel document.

2. Any audits you have conducted investigating asbestos management in your social housing stock in the past 10 years.

In addition to the audits/checks above, we audit all communal areas within all blocks (including ones which do not contain asbestos) on a six-monthly basis. For those blocks containing or presumed to be containing asbestos, the condition of the asbestos is checked. A redacted output of a 6 monthly audits of the communal areas surveyed is contained in the "6 Monthly Communal Audits" on the attached Excel document.

3. Whether you have received any claims relating to asbestos exposure since 2010; if so, how many and what was the outcome of the claim(s)?

Response:

Since 01.01.2023 to 31.07.2025 we have logged ASB incidents - cases for Shetland Close as a locality that relates to blocks 8 - 24 - 26 - 42 & 44 - 60.

Throughout this period, we have logged 10 Anti-Social Behaviour cases as follows which relate to a variety of different dwellings at Shetland Close and from multiple residents. Please note that all ASB relating to Shetland Close is only logged by Derby Homes and not Derby City Council. Separately incidents reported to Derbyshire Police are recorded independently by them.

In addition, only anti-social behaviour is recorded here as dog fouling and fly tipping is recorded under Housing Management Tenancy breaches.

- Noise nuisance x 4, all are closed. Damage to property was also incorporated in a noise nuisance case.
- Drug related issues x 2.
- Verbal abuse and threatening behaviour x 5

In relation to recorded Housing Management Tenancy breaches:

- Fly-tipping: 0
- Dog fouling: 0
- Communal area issues (items left in communal lobby): 10 (inspections completed and issues identified).
- Bi-monthly Flat Inspections for: external area litter, bin stores, shrub beds/grassed areas, communal boundary fencing and gates, hazards: Internal and external, drying areas, repairs and maintenance: Internal and external, graffiti: Internal or external, cleanliness of lobby, stairwell, walls and doors, corridors, and landings. Records held for this period are November 2023, January 2024, February 2024.

The Council, in consultation with the Derby Homefinder Landlords, reserves the right to change the percentage of properties allocated to the Corporate Needs Band, Priority Needs Band & General Needs Band to meet housing demand within the city.

The current percentage aimed for is 60% to Corporate Needs band, 39% to Priority Needs band and 1% to General needs band.

For clarity, where households are placed into accommodation outside of Derby as part of homelessness duties, this information is not collected in a way that can be reported in the format requested.

We do not record or report on whether households or individuals placed under the prevention or relief duties have refugee status, nor do we hold data broken down by local authority area.

As such, we are unable to provide the figures you have requested.
